All Together NM Fund grants \$715k to micro-businesses across the state

Grants made to 137 New Mexico small businesses and entrepreneurs via 4 entrepreneurial support organizations

NEW MEXICO, June 18, 2020: Beginning in late April 2020, to date, the All Together NM Fund (ATNM Fund)—an initiative of the New Mexico Coalition of Community Foundations in partnership with the Governor's office—has allocated \$715,000 to 137 New Mexico small businesses and entrepreneurs via four entrepreneurial support organizations (ESO's): DreamSpring, WESST, NM Community Capital, and Rio Grande Community Development Corporation. "By partnering with these four strong intermediaries, our coalition was able to lean on their expertise and streamline the award process," said Lisa O'Brien, Foundation Director, Taos Community Foundation. "It has strengthened our decision-making process as a coalition."

Micro-businesses grantmaking through the ATNM Fund provides crucial support for small businesses with staff of five or less and entrepreneurs impacted by the COVID-19 pandemic that have been ineligible for economic relief through the CARES Act. "The effects of COVID-19 on New Mexico businesses have been devastating. Those that will have the hardest time recovering are our state's small businesses and entrepreneurs," said Randy Royster, President & CEO of the Albuquerque Community Foundation. "As we look to rebuild during COVID, we know the importance of supporting our local business community, especially businesses owned by women, Native Americans, people of color, immigrants, refugees and veterans. As our state pulls through this economic crisis, it is critical to ensure all businesses have been supported and have a place in our future recovery and growth."

As a statewide initiative, the ATNM Fund is having an impact in all local New Mexico communities. "Supporting local microbusinesses throughout southern New Mexico is an important role for our community foundation team," said Terra Winter, PhD, President & CEO, Community Foundation of Southern New Mexico. "During this unprecedented time, it is vital for each of us to support our local businesses, their employees and the communities they serve in order to minimize the long-term economic impacts."

In partnership with the Governor's office, the New Mexico Coalition of Community Foundations continues to monitor the emerging needs of our state and meet those needs head on.

ATNM Fund Project Scope

The New Mexico Coalition of Community Foundations spearheaded the idea and coordinates the fund. Its member organizations include: the Albuquerque Community Foundation, the Community Foundation of Southern New Mexico, the Santa Fe Community Foundation, and the Taos Community Foundation. These organizations, in turn, work with the larger philanthropic community across New Mexico and consult with the State of New Mexico to determine the most urgent needs to be addressed though grantmaking from the ATNM Fund.
